Please note that our next meeting is **Sunday, 3/25, 12:30pm, Central High School (this is the convention)**. Set-up will start at noon, members & volunteers are asked to arrive by 12:30, doors open at 1, convention starts at 2 (Ramsey Cty convention starts at 1:30).

1. Issue for Vote. Mark Juberg was elected as a delegate from 4-1. On his sign-in card, he listed an incorrect address. When the incorrect address was checked against the VAN, it was concluded that Mr. Juberg lives in 4-2. Based on this misunderstanding, 4-1 1st alternate Cathy Magnuson was elevated to delegate status from 4-1, based on a prior credentials committee vote. Eric finally connected with Mr. Juberg, who verified his correct address and demonstrated that he actually does in fact live in 4-1. Based on this, motion to name Mark Juberg as a delegate from 4-1, and to restore Cathy Magnuson to 1st alternate status from 4-1. Seconded, passed (unanimously).

2. Ramsey County Convention Delegates. Most of the delegates to the SD 64 convention will also be delegates to the Ramsey County convention, which starts at 1:30 in the same location. However, a few people may come to the sign-in tables who are delegates to the county convention from other SDs. These folks will of course not show up on our list. Table staffers were instructed to send any such people to the county sign-in station, which will likely be at one end of our sign-in table.

3. Yarn for Lanyard Badges: Mary Horan very kindly offered to obtain the yarn and cut the necessary number of yarn hangers for the lanyard badges. Anyone who wants to help her should get in touch.

4. Credentials Problems & Visitor Pass Procedure: Any credentials issues, or request for visitor/campaign/press passes should be referred to Eric.

5. Sign-In Practice. Attendees practiced using the sign in/sign out procedure developed by Eric, using iPads linked to Eric's laptop.

6. Upgrades. Shortly after the 1st credentials report, Eric will have a list of alternates to be upgraded. These individuals will be asked, via announcement from the dais, to go to the credentials table and obtain their delegate credentials. Alternated will be upgraded in the order of their rank. Upgraded alternates will keep their alternate badges and will be given a second, "generic" delegate badge. On the system, we will record the delegate whose spot the alternate has taken. If that delegate subsequently shows up, s/he will be give his or her individual delegate badge, and the alternate will be assigned to another delegate who has not shown up or who has left. If all the delegates for a preceinct are in attendance, the alternate will be downgraded to alternate status again. Only in that event will we need to physically track the alternate down and retrieve his/her delegate credentials.
